SAFRA LIL' STARS PARTICIPATION TERMS & CONDITIONS – VOCAL / DANCE CATEGORY

In participating in the SAFRA Lil' Stars 2019 – Vocal / Dance Category, you are deemed to have read, understood and agreed to be bound by the following terms and conditions:

1. ELIGIBILITY

- 1.1. The **Vocal and Dance Category** is open to all Singaporeans and Permanent Residents (Singapore), between the ages of **5 to 12 years old** as at **31 December 2019**.
- 1.2. Foreigners or student pass holders are not eligible to participate in the contest.
- 1.3. Champions (except for Family entries) from past 2 consecutive years of SAFRA Lil Stars for Vocal and Dance Categories are not eligible.
- 1.4. All required fields must be completed and signed by a parent or guardian. Incomplete forms will not be considered.
- 1.5. Registrations closes on **Mon, 10 Jun 2019, 2359h**.

2. REHEARSAL SCHEDULE

- 2.1 A rehearsal will be scheduled only for the round of Heats on **Fri, 21 Jun 2019, 1800h to 2030h** at SAFRA Toa Payoh Atrium, Level 1.
- 2.2 Rehearsal date and time subject to change. Participants will be notified via email on any changes. There will be **no** rehearsal(s) scheduled for finals.

3. HEATS SCHEDULE – SUN, 23 JUN 2019

- 3.1. Heats schedule will only be advised via email within 5 working days after the registration closes.
- 3.2. Heats schedule is final. Participants are not allowed to change their stage timings and are required to adhere strictly to their reporting timing.

4. FINALS SCHEDULE – SUN, 6 JUL 2019

- 4.1. Finals schedule will only be advised via email within 3 working days after the Heats round.
- 4.2. Finals schedule is final. Participants are not allowed to change their stage timings and are required to adhere strictly to their reporting timing.

5. JUDGING CRITERIA AND SELECTION

- 5.1. 10 Finalists (Top 9 + 1 Wild Card Participant) will be chosen from all entries for both Vocal and Dance Category. All family entries will proceed straight to the Finals.
- 5.2. Top 3 Finalists will be selected as the Winners for their respective entries and categories.
- 5.3. Judging Criteria as follows: Originality (10%), Technical Ability (40%), Stage Presence (40%), and Overall Performance (10%).
- 5.4. Judges' decisions on the results are final. No appeal shall be entertained.
- 5.5. **Wild Card Participants:**
 - i. Any Participants who did not make it to the Finals through the round of Heats with the judges' scoring will be given the opportunity to join the other Finalists as the Wild Card Participant. 1 Wild Card Participant per entry and category, up to 4 solos and 2 groups.
 - ii. Chances are determined by 70% audience voting and 30% judges scoring.
 - iii. Audiences are allowed to only one vote per participant that they wish to support. Voting will only be allowed during the Heats.

6. MUSIC

- 6.1. Participants may submit songs and/or music of any language with no explicit languages in mp3 format via email to Amanda at lamanda@safra.sg by **Fri, 14 Jun 2019**. The Organiser will not be responsible for providing any music tracks required by the Participants.
- 6.2. Participants are required to adhere to the timing allowed on stage: 1 minute 45 seconds – Heats and 3 minutes – Finals.
- 6.3. Music exceeding the stage timing allowed will be forced-stopped during the performance.
- 6.4. Participants are encouraged to bring along a back-up copy of their music on event days.
- 6.5. The Organiser will not be responsible for poor quality playbacks of technical malfunctions due to defective, wrong formats submitted.
- 6.6. In the **Vocal Category**, instrumental accompaniment is allowed, but will not be judged. Participants are to provide their own musical instruments (if any) and it is of the Participants' responsibility to inform the Organiser on any instruments to be used to performance so as to provide adequate technical support. 1. ELIGIBILITY

- 1.1 The **Visual Arts Category** is open to all Singaporeans and Permanent Residents (Singapore), between the ages of **5 to 12 years old** as at **31 December 2019**.
- 1.2 Foreigners or student pass holders are not eligible to participate in the contest.
- 1.3 All required fields must be completed and signed by a parent or guardian. Incomplete forms will not be considered.
- 1.4 Registrations closes on **Mon, 10 Jun 2019, 2359h**.

2. RULES & REGULATIONS

- 2.1 Participants are required to register at least 30 minutes before the start of the competition. Any late comers may still be accommodated however, with no time extension allowed.
- 2.2 In the **Colouring Category**, Participants will be given a total of **2 hours** to complete the coloring for a given template (size: 30 x 30cm). Only 1 final artwork to be submitted for judging.
- 2.3 Colouring mediums allowed are colouring pencils and/or oil pastels. Participants may decide to use either one or both.
- 2.4 Participants are only allowed to use the coloring materials provided by the Organiser.
- 2.5 In the **Drawing Category**, Participants will be given **3 hours** to draw and colour their artwork. Any incomplete artwork will be deemed as disqualified.
- 2.6 Participants will be given an empty cotton canvas (size: 40cm x 40cm) and only 1 final artwork to be submitted for judging.
- 2.7 Colouring mediums allowed are coloring pencils, oil pastels, and/or Acrylic Paint. Participants may decide to use any one or combination of the three.
- 2.8 Participants are only allowed to use the materials provided by the Organiser.
- 2.9 In the **Drawing Category**, submissions which copied the composition of existing works will automatically be disqualified, even if they are rendered in a different style, medium, colour scheme, or even if other elements have been added.
- 2.10 The submitted entries shall be the property of the Organiser and the Organiser reserves the right to use and/or amend the images for any practicality use. Participants may write in to the Organiser to retrieve their submissions after the competition, subject to approvals.

3. JUDGING CRITERIA AND SELECTION

- 3.2 All Drawing entries will be judged based on: Technicality (30%), Originality & Creativity (30%), Relevance to the Theme (20%) and Overall Attractiveness (20%).
- 3.3 There will be 3 winners for each of the age group category.
